Motion by Jes Stevens to approve emergency installation of new Teacher House Water Heater at a cost of up to \$3,000.00.

Second by Felicia Dunson. Motion passed unanimously.

- 2. TH Basement had water in it after recent heavy rains. Committee inquired and caretaker agrees that installing a sump pump is a good step.
- Grounds: Axiom has placed a distribution box on the Teacher House

property that blocks the uphill access to the Teacher House Property. The Committee will write a letter to Axiom and the Assessors to ask why the box was placed where it is and if it can be moved.

• Little Teacher House: water has been turned on.

Initial security deposits and rent payments have been received from new tenants.

■ Property Manager & Caretaker Report: Jes Stevens has received water tests for TH and LTH. She hopes to send samples in for testing on the boat tomorrow, Wednesday.
